(h) To provide for the welfare of labour,

(i) To provide for the uplift of villages and providing necessary amenities for the benefit of villagers,

(j) to provide for flood and famine relief works,

(k) to promote Indian culture, Art and Science,

(l) To promote the welfare of the people politically and economically,

(m) To establish and donate community halls and meeting halls for the propagation of the welfare and uplift of the people and;

5. The management, control and supervision of the Trust shall be vested with all the Trustees. Sri M.S.Chockalingam and Sri C.Sunderam shall be the Managing Trustees for their lives.

6. The present Managing Trustees shall be entitled to nominate their successors. After their life time, the Board of Trustees shall be entitled to elect a Managing Trustee or two Managing Trustees.

7. The Trustees shall be entitled to invest Trust Fund according to their discretion either in Joint Stock Companies or in the purchase of Stocks, Shares and Debentures of such Companies or in Banks or on the first mortgage of immovable properties and they shall be entitled to use the income or the corpus, if the donor so desires, to carry out the purposes of the Trust.

8. The Trustees shall keep a true and correct account of the Trust monies and the disbursements thereof and the accounts shall be closed at the end of 31st March every year and shall be audited every year.

9. The Trustees shall have power to convert such investments in any manner for the benefit of the Trust.

10. The Trustees shall have power to transfer the funds to authorities or Trustees or Managing Committees of anyone or more of the educational institutions of the kind referred to above as they may deem fit.

11. There shall be a minimum of three Trustees and a maximum of seven Trustees and the Trustees may co-opt such number of Trustees as they may deem necessary within the maximum strength provided and any vacancy arising in the office of Trustees shall be filled by the remaining Trustees by co-opting any person to the office of a Trustee, provided that if the number of Trustees at any time is reduced to below four, such remaining Trustees or Trustee may act for the purpose of co-opting a person or persons as Trustee or Trustees.

12. The Trustees shall act as a board and all matters coming up for consideration by the board shall be decided by a majority of the Trustees present at the meeting. The chairman of the meeting of the Trustees shall have, in addition to his own vote, a casting vote in the case of an equality of votes. Any resolution circulated to all the Trustees and assented to by a majority of them shall be deemed to be a resolution of the board of Trustees.

13. The Trustees shall be entitled to frame bye-laws and rules providing for the conduct and management of the Trust and shall likewise have power to amend, modify or cancel substitute and add any bye-law or rule that may have been framed.

14. The Trustees may nominate one or more persons of their body by name or otherwise to be in custody of any of the assets of the Trust, to hold properties and assets of the Trust in his name or their names for and on behalf of the Trust and to execute all documents contracts and deeds for and on behalf of the Trust.

15. The Trustees shall specify and nominate one or more persons who shall be entitled to institute conduct or defend all suits and legal proceedings, to receive service of summons and processes, to sign pleadings, complaints, vakalats, statements and affidavits for and on behalf of the Trust in respect of all proceedings before any court or other authority.

16. The Trustees may borrow from time to time such sum or sums of money at such rate of interest for such period and on such terms with or without security moveable or immoveable as the Trustees may think fit and to secure payment thereof with or without interest by mortgage or by bond, promissory notes, bills, hundies and other negotiable securities or by issue of debentures.

17. Whenever for the administration of the Trust hereby created or for the establishment, development and conduct of the several institutions maintained by the Trust, grant in aid or loans from Government are applied for and obtained and it becomes necessary for the due performance of the conditions of such grant or loan to secure the same by a mortgage or charge on the properties of Trust, the Trustees shall have the power to create such mortgages or charges on all or any of the Trust properties to facilitate the obtaining of such grant for purchase of lands, for administration, conduct and maintenance of such institutions.

fit that the expressions therein restrictive in their scope and though emphasised only the promotion of welfare of people and are liable to be misconstrued as enabling the trustees to entertain any political objective which was not the intention of the signatories of founders of the aforesaid trust and whereas the trustees have been advised that in the circumstances and to obviate any confusion it is desirable that the said controversial clause be deleted and with a view to effectuate the said desire.

Now this instrument witnesseth that the trustees do hereby rectify the said deed dated 30-3-1970 made by us, the signatories, by deleting clause 4(L) i.e., the clause reading 'to promote the welfare of the people politically and economically' and declare that the said clause shall be deemed to have been always deleted from the said trust deed; and further renumber clauses (m) and (n) therein as clauses (l) and (m) respectively, declare that the object of the trust is for public and charitable educational purposes and that the aforesaid rectification is only to remove any mis-construction as to the object of the trust which is hereby set at rest by this deed of rectification and declaration.
